The aim of the project was to create an information system for the management of examination questions (IS SPOT), which is designed to support the management of examination sets intended for professional examinations according to individual legal regulations, in particular:a:

- Act No. 257/2016 Coll., on Consumer Credit, as amended,
- Act No 256/2004 Coll., on capital market business, as amended,
- and Act No. 170/2018 Coll., on the distribution of insurance and reinsurance, as amended.

- In the IS SPOT solution, all questions and case studies for individual exam sets managed by the Administrator and the CNB Expert are imported for preview by the Ministry of Finance Expert, Language Proofreader and Accredited Person Representative.
- Within the application, it is possible to submit a change/ modification to a question or case study, request that it be removed, or submit a suggestion for a completely new question. These suggestions can be made by a CNB Expert, MF Expert or Accredited Person Representative.

THE FOLLOWING MENUS ARE AVAILABLE TO THE GENERAL PUBLIC WITHOUT LOGGING IN:

- Home, where the exam sets are published in PDF and XML.
- Display of regular statistics, when it is an evaluation of statistical data on the success rate of individual professional exams.
- Run test interested members of the public can generate a sample or full-length test for any professional exam, try to complete the test and then have it evaluated. He/she will get feedback on the questions/case studies answered correctly, how many points he/she scored out of the maximum possible, what was the success rate of the test.



THE MOST COMMONLY USED TECHNOLOGIES AND SOLUTIONS:

- Within the implementation of the subject of performance, the full functionality of the new IS SPOT system was created in the Oracle environment.
- The user interface of IS SPOT is implemented using the Oracle APEX application platform.
- The delivery also included integration to the internal systems of the CNB).



HANDOVER OF THE SOLUTION INTO PRODUCTION AND COMMENCEMENT OF LIVE OPERATION:

- The entire IS SPOT solution was launched on 1 June 2023.
- The delivery included delivery of a feasibility study (analysis), implementation, creation of test scenarios, training of internal CNB staff, subject matter administrators and IS SPOT users, testing, resolution of errors found in the tests, assistance with penetration testing, piloting, documentation and import of historical data.
